Facts: The transponder showed an incorrect driver ID at pit exit.
Offence: Breach of Article 61 of the Blancpain GT Series 2018 Sporting Regulations and Sporting Note #3.
Decision: **Fine €500 (Five Hundred Euros)**
Reason: Timekeeping data shows that an incorrect driver ID was recorded at pit exit following the pit stop of the car. The Stewards determine that this is a breach of Article 61 of the Blancpain GT Series 2018 Sporting Regulations and Sporting Note #3 and apply a penalty in accordance with Article 61.

The Competitor is reminded of his right of appeal in accordance with Article 15 of the 2018 FIA International Sporting Code.

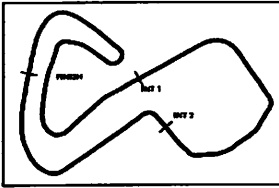
