The Stewards, having been apprised that Mr Dumas is at Nurburgring Nordschleife undertaking activities associated with the Volkswagen I.D. R, find the driver in breach of Article 25 of the 2019 Blancpain GT Sporting Regulations.

The Stewards impose a penalty of an obligation to accomplish some work of public interest (ISC 12.3.1.c), specifically:

- o To prepare and deliver (in French) to track marshals and volunteers a presentation of at least 30 minutes explaining why Romain Dumas was not present at Silverstone as he was required to be, and to describe his activity with the Volkswagen I.D. R both at Pikes Peak and at the Nurburgring Nordschleife (with Qs & As afterwards)
- o The presentation to be made during the 2019 Total 24 Hours of Spa at an exact date/time/venue to be determined

Additionally, the driver must be apprised of the full content of the Drivers' Briefing by the Team Manager before taking part in any track activity.

The Competitor is reminded of his right of appeal.


