- Crossed the white line at pit lane: entry  exit
- Exceeded the speed limit in the pit lane with a speed of 55.4 km/h
- Did not respect yellow flags  repeatedly
- Did not respect track limits  repeatedly
- Made a false start
- Caused a collision
- Forced a driver off the track
- Illegitimately impeded another driver during overtaking
- Pit lane infringement.....
